



Secure Survey Login

July 2026

The Defense Organizational Climate Survey (DEOCS) and the Defense Organizational Climate Pulse (DOCP) are two survey tools that provide commanders and other Department of War (DoW) leaders with important feedback about the current command climate within their unit or organization. This document provides survey administrators, commanders, and DoW leaders with an overview of the secure survey login system, help with addressing login issues, and how participants' information is safeguarded.

About the Secure Survey Login

The secure survey login process is how participants access the DEOCS or DOCP survey. This process allows participants to access the surveys by entering their DoD ID, e-mail address, or phone number into a universal login page, without the need for survey administrators to distribute passcodes. The secure survey login process allows the DEOCS and DOCP systems to automatically distribute survey access information straight to participants if an e-mail address was provided on the roster.¹

Some of the benefits of the secure survey login system include:

- **Easy Access.** Participants can access the survey via a link automatically sent to their e-mail, rather than waiting for survey administrators to send a passcode.
- **Automated Outreach.** Recruitment and reminder e-mails will automatically be sent to all survey participants included on the roster.
- **Decreased Burden on Survey Administrators.** Survey administrators will no longer be required to distribute a link to the survey for their unit or organization.
- **User Authentication.** Only participants included on that unit's or organization's roster will be able to take the survey.
- **Enhanced Data Protection.** Once participants submit their survey, they will not be able to take the survey again.
- **Additional Data Analysis Capabilities.** The data can be weighted and compared across units and organizations and over time.

This section will provide survey administrators, commanders, and leaders with more detail about the secure survey login process and how it impacts participants' access to the DEOCS and DOCP survey, as well as tips to troubleshoot any issues participants may experience when accessing either survey.

How the Secure Survey Login Process Works

To access the secure survey login, all participants with an e-mail provided on the roster are automatically sent an e-mail from the Office of People Analytics (OPA) Defense Command Climate Portal (DCP) informing them that their DEOCS or DOCP survey is available and encouraging their participation. Survey administrators will need to provide the survey link to participants without an e-mail on the roster. Participants will then enter their DoD ID, e-mail, or phone number to access their survey.

Registering a survey. To register a DEOCS or DOCP survey, survey administrators must **upload a roster** containing the name and contact information of all individuals in their unit or organization. This roster will ensure that only the individuals within that unit or organization are eligible to take that unit's/organization's DEOCS or DOCP survey.²

Inviting participants. Once the survey starts, all individuals included in the roster that have an e-mail listed will **receive an automatic e-mail with the link to the survey**. While an e-mail is automatically sent, it is still recommended that survey administrators or commanders inform their members that the survey is available and encourage their participation through as many communication methods as possible. The links for the surveys are the same for all units, organizations, and subgroups and can be distributed widely. The link to the DEOCS is: <https://www.surveysdrc.com/DEOCS>. - Note: Individuals that do not have an e-mail address listed on the roster will not receive an automated e-mail from the system.

Taking the survey. For participants to take their DEOCS or DOCP survey, there are four main steps that accompany the secure survey login process.

1. **Match to an active registration.** Participants will enter their DoD ID, e-mail address, or phone number on the survey webpage (<https://www.surveysdrc.com/DEOCS> or https://www.surveysdrc.com/DOCP_C). The information a participant enters **must match** the information that was provided on the roster during registration (i.e., the DoD ID, e-mail addresses, and/or phone number). If the information participants enter does not match what is listed on the roster, participants will receive an error message.

2. **Confidential match to administrative data.** An additional matching process attempts to match participants to the DoW's master administrative records. If the system is unable to match a participant based on the information they provided in Step 1, they will be prompted to provide their DoD ID on a different screen.
3. **PIN creation.** With secure survey login, participants have the option to save their responses and return later to complete their survey. Participants will create a PIN during login that will allow them to re-enter their survey if needed. If a participant forgets their PIN, they will **NOT** be able to retrieve it and will not be able to re-enter their survey.
4. **Consent to take the DEOCS or DOCP survey.** Once the participant matches to the roster, prior to accessing their survey, they must consent to taking the survey. After consenting, the participant can begin the survey.

How to Troubleshoot Secure Login Issues

Below is a list of solutions for participants who are having survey access issues.

- **Ensure individuals enter the correct survey website.**
 - To access the DEOCS, participants must visit the following website: <https://www.surveysdrc.com/DEOCS>. To access the DOCP, participants must visit the following website: https://www.surveysdrc.com/DOCP_C.⁴
 - **Security Barriers:** If participants are accessing the surveys within a government or military network, firewalls may block access. If this occurs, ask your local IT support to whitelist the survey websites listed above. Individuals can also access their DEOCS or DOCP survey through their personal device, such as a laptop, mobile phone, or tablet.
- **Ensure individuals enter the correct DoD ID, e-mail, or phone number.** Any information that a participant enters must match the information provided by the survey administrator included on the roster. The roster information entered could be any combination of DoD ID, e-mail(s) (DoD e-mail and/or a personal e-mail), and phone number (work or personal). Survey administrators should double-check the roster they uploaded during survey registration and provide guidance to participants on which information to enter.
- **Ensure individuals are entering the correct PIN.** The current system cannot recover forgotten PINs and participants are not able to create a new one. In the case of a forgotten PIN, any questions answered prior to saving the survey or being timed-out due to inactivity will be submitted when the survey closes.
- **Direct individuals to the participant troubleshooting document.**⁵

Participant Privacy

The Department of War is committed to safeguarding the information of Service members and DoW civilians who take the DEOCS and DOCP survey. This section outlines the privacy and security standards that the surveys follow. As discussed above, to access the surveys, individuals are asked to enter their e-mail, phone number, or DoD ID. The surveys have privacy policies and secure technology in place to protect all personally identifiable information (PII).

Privacy Policies

- **We only report results for subgroups with five or more participants.** OPA reports results to unit commanders and organization leaders at the overall unit or organization level as well as by certain subgroups, such as those designated by the command and those based on sex, race, ethnicity, or pay grade. The presentation of results for different subgroups enables commanders and leaders to better understand the nuances of their unit's or organization's command climate and ensures that no group is overlooked. To protect participants' privacy, commanders and leaders will only receive subgroup reports for closed-ended questions if at least five participants respond. If your survey included multiple subgroups and only one subgroup had fewer than five responses, it will be combined with the reportable subgroup that had the next lowest number of participants. For example, if subgroups included on a DEOCS were "Administration" with three participants, "Operations" with six participants, and "Logistics" with nine participants, the "Administration" subgroup results would be combined with the "Operations" subgroup results.
- Additionally, for subgroups based on respondent identified demographic characteristics, subgroups are considered in sets (i.e., junior enlisted and senior enlisted). If one subgroup in a set does not have five or more participants, no subgroups in that set are reported. For example, if there are three senior enlisted respondents and nine junior enlisted respondents, neither subgroup is reported.
- **Participants' privacy will be protected in combined reports.**⁶ For combined DEOCS reports, if only one subgroup out of the selected had results that were not reportable for a given factor, demographic category, or question, all results for the given item(s) will not be displayed. This protects the one nonreportable subgroup. For example, nine of the 10 subgroups selected for a combined report have reportable results for *Cohesion*, but one has a not reportable result for *Cohesion*. The combined report must exclude results for *Cohesion*. 10 subgroups are selected for a combined subgroup report. Alternatively, if not

enough individuals respond initially, a combined report can be created that displays results if there are results for five or more participants. All 10 subgroups did not display results for male and female participants because fewer than five males and five females responded to the questions. When combined, more than five males and five females responded to the questions, so results for male and female participants are included in the demographic category charts.

- **Our practices meet the highest standards of records management and privacy.** The OPA team has decades of experience collecting and storing sensitive personnel data on behalf of the DoW. Our practices are compliant with all DoW policies regarding information collection.
- **Confidentiality.** Survey answers are confidential to the extent that the law permits. Under state and federal law, certain circumstances may require us to break confidentiality. For example, if a participant indicates a direct threat to harm themselves or others within their responses.
- **Survey administrators, commanders, and leaders cannot view who has completed a survey.** Your responses are combined with the responses of everyone in your unit or organization to produce results of the entire group or subgroup. Consistent with industry-standard practices, personally identifying information from survey rosters (e.g., e-mail address) is used within the survey system for outreach purposes and identity verification purposes at survey login (to ensure the right people are taking the survey, and each person can only take the survey once). This information is not included in the reports we provide to commanders, leaders, or anyone else in your unit or organization.
- **OPA never stores PII in the same file with survey responses.** Identifying information is always stored separately in a tightly restricted file.
- **We only publish statistics.** OPA does not identify individuals in the reports we provide to survey administrators, commanders, or leaders.

Website Privacy

- **Neither the DoW nor its survey operations contractor, Data Recognition Corporation (DRC), will collect participant PII when they visit the DEOCS or DOCP website unless participants choose to provide it.**
- **Our system does not enable “cookies.”** Cookies are files placed on a user’s computer’s hard drive to monitor their use of the website and web.
- **The DEOCS and DOCP do collect non-PII from survey participants’ visits.** This information is used to assist the DoW and our survey team in improving the website and overall performance of our web-based surveys. The data collected are listed below:
 - The Internet Protocol (IP) address for the computer or device being used to take the survey (for example, www.verizon.com, www.comcast.com, 122.3.55.34). Depending on the internet service provider, IP addresses

may identify the computer or they identify no more than the internet service provider (such as Version or Comcast).

- The device that is used to access the survey (e.g., PC, tablet, or mobile phone).
- The type and version of the browser and operating system that are used to access the survey websites.
- The date and time that this website is accessed.
- The number of bytes sent and received.
- The pages visited.

Secure Technology

- Working with top industry partners and contractors we have designed our systems with overlapping **layers of security** to protect participants' information from cyber-attack. All systems comply with NIST RMF security standards, as required by the DoW.
- Response data and PII is **encrypted** during data collection and then stored in a **secure network** isolated by firewalls and other security measures.
- We actively monitor all digital traffic and inspect our IT systems to make sure participants' information stays secure.
- To ensure that all survey responses are secure while being transmitted over the internet, the web survey application uses Secure Socket Layers (SSL) with **256-bit encryption**; when participants access the web survey, they will see the "padlock" icon displayed in their web browser.
